Chairman Carbo called the meeting to order at 7:00 PM.

To the residents and tax-payers of the Town of East Haven, and other interested parties, due to Governor Ned Lamont's March 10, 2020 declaration of a public health emergency and civil preparedness emergency and subsequently issued Executive Orders, and Mayor Joseph A. Carfora's March 16, 2020 declaration of a state of emergency in the Town of East Haven due to the spread of Coronavirus Disease 2019 in the State of Connecticut including New Haven County, in-person public access to this meeting will not be permitted.

8. Public Comment

- a. Karen Martin (15 Oak Grove Road)
 - i. Golf Carts seeking clarification whether or not golf carts are legal on the street. She recalls discussion of this issue pre-pandemic at a previous monthly meeting about a year-and-a-half ago*. Chief Lennon explained that if the Town has a specific ordinance allowing it in beach communities up to a certain mileage away from the shoreline, then they are allowed. Commissioner DiSilvestro cited CT general statute 14-300G noting that specific criteria must be met. Ms. Martin also mentioned witnessing a quad [ATV] come speeding down Mansfield Grove Road from the D.C. Moore school area towards the beach with a toddler on the lap of the driver which she called in immediately out of concern for the child's safety.

 - iii. Beach Parking what is the plan for the upcoming season? Chairman Carbo says that plans are in the works but is not at liberty to discuss anything at this time but hopes to have more information by the next monthly meeting.

 - i. Members of the SCRSWAT Team were deployed as mutual aid to Branford Police Department for an active shooter incident on April 13.

Chief Lennon could not be prouder of our officers who responded with professionalism and employed their training.

Deputy Chief Tracy echoes Chief Lennon in expressing his pride in our officers. These are the incidents that we train for, hoping we never need to utilize that training, but when called into action, they did just that. He has no doubt in his mind that their actions saved the lives of other officers and also innocent bystanders.

Vice Chairman Balletto said that he has spoken with several people from different law enforcement agencies throughout the region, and they all talked about how well East Haven

ii. In a joint meeting with the Superintendent's office, School Resources Officers (SRO) have been selected. Officer Nicole Burrell will be the SRO at East Haven High School and Officer George Gerosa will be the SRO at Joseph Melillo Middle School starting in August 2021 for the start of the new school year.

11. Old Business

Vice Chairman Balletto asked Clerk Maldonado about any outstanding issues pending review and recommendation from the Traffic and Public Safety Committee. He would like to scheduling a committee meeting to discuss.

12. New Business

a. Approval of road closure request for the East Haven Annual Fireworks – June 26, 2021 (rain date June 28, 2021)

Chief Lennon explained for new commissioners that in order to close roads for special events and also to obtain highway use permits for state roads such as Hemingway Avenue near the Town Green, Local Traffic Authority [which is the Board] approval is required.

Vice Chairman Balletto made a motion to approve the road closure request for the East Haven Annual Fireworks – June 26, 2021 (rain date June 28, 2021); seconded by Commissioner DiSilvestro. Voice Vote: All in favor. No one opposed or abstained. Motion carried unanimously.

b. Approval of road closure request for the East Haven Proud Motorcade and Town Concert – August 21, 2021 (rain date August 22, 2021)

Vice Chairman Balletto made a motion to approve the road closure request for the East Haven Proud Motorcade and Town Concert – August 21, 2021 (rain date August 22, 2021); seconded by Commissioner Disilvestro. Voice Vote: All in favor. No one opposed or abstained. Motion carried unanimously.

c. Approval of road closure request for the East Haven Fall Festival/Road Race – September 10, 11 and 12, 2021

Vice Chairman Balletto made a motion to approve the road closure request for the East Haven Fall Festival/Road Race – September 10, 11 and 12, 2021; seconded by Commissioner DiSilvestro. Voice Vote: All in favor. No one opposed or abstained. Motion carried unanimously.

d. Consideration and approval to install a crosswalk at Cosey Beach Avenue by Coe Avenue

Chief Lennon explained that while evaluating the parking needs in the area, it came to our attention that all three (3) corners of the three-way intersection needed a crosswalk. Also, the YMCA camp is at that location, and it will ensure the safety of pedestrians – especially children who, instead of crossing two road ways, would only have to cross one road way from the drop-off location in the Town Grove parking lot on to Cosey Beach Avenue to the location.

Vice Chairman Balletto made a motion to approve the installation of crosswalks at the 3-way intersection at Cosey Beach Avenue and Coe Avenue; seconded by Commissioners Romans and DiSilvestro. Voice Vote: All in favor. No one opposed or abstained. Motion carried unanimously.
