#### 8. Public Comment

Lorena Venegas (73 George Street) – Suggested a more detailed monthly Chief's Report similar to the 50-page report from the Town of Trumbull citing a lack of mental health services in our Town and asked for the Board to help her advocate for more behavioral mental health services in Town instead of outsourcing to BHcare.

- a. Personnel Matters/Injured Employees
  - i. One (1) vacancy with the request for retirement tonight; and one (1) vacancy due to an Academy Recruit resignation who decided this was not the career for him. Background investigations are in progress in anticipation of filling this recruit position.
  - ii. Academy seats are secured for a tentative start date in April 2022; requests a special meeting in March for hiring once the backgrounds are completed.
  - iii. Sworn Personnel: one (1) remains on long term injury with no return to full duty date at this time.
