Chairman Carbo called the meeting to order at 7:00 PM.

7. Consider and act upon Committee Reports & Recommendations

Each recommendation as outlined in the **Traffic & Public Safety Subcommittee Special Meeting Minutes** of **December 7**, 2021 was presented to the full Board for discussion and action as follows:

a. Shoreline Greenway Trail Plan Presentation by Town Engineer Jonathan Bodwell

Commissioner DiSilvestro made a motion to approve the plan as presented subject to several recommended changes; seconded by Commissioners Romans and Barbuito. Voice Vote: All in favor. No one opposed or abstained. Motion carried unanimously.

b. MaryAnn Salemme (132 Burr Street) and Residents, dated July 28, 2021 – Request for 3-way stop signs at the intersections of Burr/Haines and Burr/James - *from the Monthly Meeting of August 31* 2021

Commissioner DiSilvestro made a motion to take no action; seconded by Commissioner Romans. Voice Vote: All in favor. No one opposed or abstained. Motion carried unanimously.

c. Crest Avenue - Request for a NO PARKING ZONE

Commissioner DiSilvestro made a motion to approve the request; seconded by Commissioner Romans. Voice Vote: All in favor. No one opposed or abstained. Motion carried unanimously.

d. Lorena Venagas (Email dated September 17, 2021) – Request for crosswalk at Coe Avenue/Wilkenda intersection – *from the Monthly Meeting of September 28*, 2021

Commissioner DiSilvestro made a motion to take no action; seconded by Commissioner Romans. Voice Vote: All in favor. No one opposed or abstained. Motion carried unanimously.

e. Christopher Griswold (714 Laurel Street), Undated; Received September 13, 2021- Modified request to remove stop sign at the intersection of Laurel Street/View Terrace – *from the Monthly Meeting of September 28*, 2021 and November 30, 2021

Vice Chairman Balletto made a motion to deny the specific request to remove the stop sign in lieu of installing STOP AHEAD and STOP signs on the northbound side (going towards New Haven) thereby making the intersection at Laurel Street and View Terrace a 3-way stop; seconded by Commissioner DiSilvestro. Voice Vote: All in favor. No one opposed or abstained. Motion carried unanimously.

8. Public Comment

Karen Martin (15 Oak Grove Road) – Thanks the Board for their consideration of the crosswalk request at Coe and Wilkenda; however, she wonders if there are other things that can be done to slow down traffic such as posting a solar-operated speed limit sign or the speed trailer. Vice Chairman Balletto commented that there would be traffic enforcement leading up to and throughout the completion of the Shoreline Greenway Trail.

Update on NO DUMPING on Saber Street – Deputy Chief Tracy looked in to this and it was determined that this area is not Town property, however, Zoning did reach out to the property owner to make the suggestion that a sign might preclude the behavior from continuing. He is awaiting a response from the homeowners to help facilitate the purchase of a sign, if they so choose.

- 9. Correspondence Received/Sent
 - a. Michael Roy (35 River Road), dated December 15, 2021; received December 20, 2021 Request for traffic enforcement and a speed study, and possibly installing speed bumps, on River Road to address excessive speeding.

Chairman Carbo made a motion to defer this to the Traffic & Public Safety Committee for review; seconded by Commissioner Romans. Voice Vote: All in favor. No one opposed or abstained. Motion carried unanimously.

- 10. Department Updates (Chief Lennon)
 - a. Personnel Matters/Injured Employees
 - i. Sworn Personnel: one (1) remains on long term injury; one (1) remains on light duty. No return to full duty date at this time.
 - ii. Four (4) recruit officers remain in various stages of Field Training (FTO); one (1) recruit officer is in the Academy.
 - iii. Chairman Carbo asked if we are now at full compliment. Chief Lennon replied that we are "on paper" but that some officers are injured or in various stages of training, and he anticipates an upcoming retirement. In preparation over the next several months, we have initiated candidate backgrounds and requested Academy seats for spring.
